- the Cargo Agent's Handbook containing the complete text of certain IATA Resolutions applicable to IATA Cargo Agents, including IATA Resolutions 016aa "Commission for IATA Cargo Agents", 805 "Cargo Agency Rules", 801a "Cargo Agency Agreement" and 833 "Ready for Carriage Consignments",

- the IATA Dangerous Goods Regulations. It is important that all your offices have a copy of these Regulations and that your staff be familiar with them and regularly update their knowledge by following appropriate courses. To this effect, additional copies are available upon request.
